SUBJECT: **Transcription Services**

Enclosed is an updated list of transcription services. If other transcription services are brought to your attention, or if you have difficulties with a service on the list, let me know. In addition, the District Office should circulate this list to the courts in their district where electronic recording is taking place. I have provided it directly to those Town & Village Courts that I've trained in the usage of the SONY BM-246.

Transcription services should be provided with a copy of the pertinent log notes and a cover page which lists, at a minimum, the parties, witnesses, and the case name and number. Keep in mind that if a transcript is purchased by one of the parties the transcription service will provide a gratis copy of the transcript to the court.

Several court system employees appear on the enclosed list of transcribers. Please be advised that their services should not be utilized to produce transcripts paid for with funds from their "home" court. Furthermore, other transcription situations where an "appearance of impropriety" exists should likewise be avoided.
